- 3. The syllabi of new the PG Course of M.A.-History and the Subject of Physical Education shall be the same as has been approved by the Kurukshetra University for the concerned Course/Subject. The College may, however, be allowed to offer the Optional/Specialization Papers to the students of the M.A.-History Course according to the Government/University norms regarding availability of sufficient number of faculty members having specialization in that particular Option/Specialization in the College.
- 4. The College may be directed to purchase standard books of Post Graduate level worth Rs Fifty Thousand (Rs. 50,000/-) for History and Rs. Twenty Thousand (20,000/-) for Subject of Physical Education respectively to run the Course/Subject smoothly. These books may be purchased in consultation with the Senior Faculty at Department of History and Department of Physical Education in Kurukshetra University, Kurukshetra.
